I/We agree without reservation that any Veterinary Surgeon operating on any of my/our dogs in such a way that the operation alters the natural conformation of the dog or part thereof may report such operations to the Kennel Club. I/We declare that where any alteration has been made to the natural conformation of the dog(s) the relevant permission to show has been granted by the Kennel Club Limited. I/We further agree that I/We believe to the best of my/our knowledge that the dogs are not liable to disqualification under Kennel Club Limited Show Regulations.

REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F (B)

1. These regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these show regulations and/or for disciplinary action under Kennel Club Rule A42. (a) A dog found to have been exhibited in breach of these regulations will automatically be disqualified from exhibition at the show and from any award gained there. (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these regulations, he/she may be subject to further penalties of either a fine or as listed under rule A42.
2. (a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show. (b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:
 - (a) Operations certified to the satisfaction of the General Committee.
 - (b) the removal of dewclaws of any breed.
 - (c) The shortening of tails of customarily docked breeds but only up to an acceptable age limit which shall be prescribed from time to time.
 - (d) Operations to prevent breeding provided such operations are notified to the Kennel Club before neutered dogs are shown. Nor must anything be done calculated to in the opinion of the General Committee to deceive.
4. The General Committee without previous notice may order an examination of any dog/dogs at any show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination & analysis.
5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by any official of the show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
6. Any objection by an individual related to an infringement of these regulations must be made in writing to the Show Secretary at his/her office before the close of the show & the individual must produce evidence of identity at the time of lodging the complaint.

The Officers & Committee of the National Chow Chow Club do accept any responsibility for any products advertised or sold by stall holders and/or trade stands at this show. Exhibitors are reminded that products on sale by trade stands for the preparation & grooming of dogs may not meet the requirements for the Regulations for the Preparation of Dogs for Exhibition.

Your dog is vulnerable and AT RISK if left in a vehicle in high temperature and even on days considered as slightly warm. Please take care of your dog.

If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.
